5. Please note that, If you are renewing your Scholarship application for the same course, you are not required to provide your income and /or caste certificate afresh/ again for the same course.

Bank Account must be in the name of the student and the Account holder must check their KYC (Know Your Customer) status and bank account must be operational/active till the scholarship is disbursed. Fill the ISFC code and Bank name correctly. Link your bank account no. with aadhar no. and mobile no. The account should not be a Jandhan account for scholarship reimbursement.
